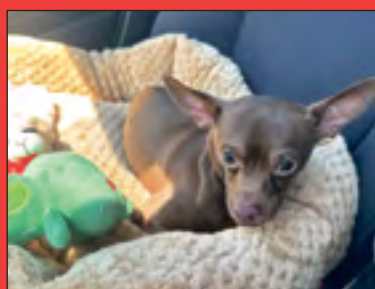

Through the graveyard to life

Zion UMC feeds record 280 families in Prosperity

PROSPERITY—For more than a dozen years, God has been feeding thousands of people through the generous hearts and hands of one congregation.

Three times a year, Zion United Methodist Church hosts a massive Saturday community food distribution it calls the Zion UMC Food Pantry.

They held their most recent event Aug. 15, that day giving out food to more families than ever before—280 families, 59 of them first-time recipients.

The Rev. Joseph James said the effort is a smoothly run, well-orchestrated system led by a relatively small church, with roughly 85 in worship each Sunday.

"In more than 30 years of ministry, I have never seen a congregation this size have such a significant and well-coordinated impact on its local community," James said, noting the event is a wonderful reminder that churches of every size can make an extraordinary difference in the communities they serve.

Brookland UMC presses on after ceiling collapse

WEST COLUMBIA—A Midlands church is reeling after the unexpected collapse of its sanctuary ceiling.

The Rev. Mark Payne said everything was normal at Brookland United Methodist Church on Sunday, July 19, when the congregation gathered for worship. But two days later, Payne got a call that utterly shocked him—the ceiling was in shambles, with huge chunks of drywall, wood and other materials crashing in.

Two Georgia conferences combine into one

S.C. delegation among voters approving merger

The North and South Georgia annual conferences are now one.

South Carolina lay and clergy delegates joined their counterparts across the Southeastern Jurisdiction for a special called jurisdictional conference session held Aug. 11, voting unanimously to approve the unification.

Both the North and South Georgia conferences approved the unification at their respective annual conferences this summer (South Georgia by 96.6 percent and North Georgia by 96 percent), and the request to unify was one they had been working toward since fall 2024 through prayerful

study, engagement, discernment and other diligent work.

The newly formed Georgia Conference will begin operations in January 2027.

"It was a profound celebration to witness the unification of laity and clergy in the noble mission of serving God's people," said South Carolina Delegation Chair Jackie Jenkins.

ORANGEBURG—Registration is going on now for the annual Africa University Wespeth-Sponsored Bishop Leonard Fairley Golf Invitational, set for Sept. 28.

Held at Orangeburg Country Club, proceeds fund scholarships and campus programs that equip Africa University students to lead and serve across Africa.

The United Methodist Church founded Africa University, located in Mutare, Zimbabwe, in 1992 as its first pan-African, private, United Methodist-related institution of higher learning. South Carolina has been one of the university’s key supporters from the beginning, and to further support AU, lay leaders in the South Carolina Conference of The United Methodist Church established the annual golf tournament 13 years ago.

Each year, more than 100 golfers from South Carolina and across the nation participate in the tournament.

This year, the tournament will include a weekend lineup of events:

- An invitation-only dinner Friday
 - A meeting of the Board and Advisory Development committees and Wespeth Stakeholders Seminar on Saturday, Sept. 26
 - An energy-packed Africa University Sunday saturation event Sept. 27 in the Orangeburg District, with at least 15 churches hosting Africa University representatives, plus worship and a special luncheon at Edisto Fork UMC, Orangeburg
- “This tournament gives another chance to enjoy supporting one of our

most excellent ministries,” South Carolina Bishop Leonard Fairley said. “It connects us to one another both locally and with our heart for ministry around the world.”

Esaunta Buncomb shared about Community Long-Term Care services, explaining how eligible individuals can receive assistance with daily living activities while remaining safely in their homes and communities. Topics included eligibility guidelines, available in-home

services, caregiver support and the application process.

Whether attendees were approaching Medicare eligibility, helping a loved one navigate the system or planning for future long-term care needs, the sessions provided valuable information, practical resources and an opportunity to ask questions and connect with knowledgeable professionals.

The afternoon ended with a lively game of bingo that brought plenty of fun, laughter and smiles to all in attendance.

5 Things to Know.

About O’Neal Street UMC, Columbia

The Advocate has started a new feature that showcases a different United Methodist church in every district throughout South Carolina with their answers to five questions. This month, get to know O’Neal Street UMC, Newberry, whose pastor is the Rev. Ed Stallworth.

1. What makes your congregation unique compared to other churches in your district?

O’Neal Street UMC is a small church on Sunday mornings, but throughout the week, we are anything but small. We have become a place where the community comes together to serve the community. In fact, our fellowship hall and food pantry see more foot traffic during the week than our sanctuary does on Sunday.

The majority of the people who regularly volunteer through our community ministries are not members of O’Neal Street. They come from other churches, civic organizations, colleges and the surrounding community. We provide a place where people can bring their gifts, their time and their desire to serve and put them to work alongside others.

That is one of the things that makes O’Neal Street special. We are not only a church that serves the community. We are a place where the community comes to serve.

2. What’s one local ministry or outreach effort your church is especially proud of, and what impact has it had?

It is difficult to choose just one because so much of our community ministry works together to meet the needs of our neighbors.

Saturday is our biggest day. Our Feed Thy Neighbor Kitchen prepares and serves a couple hundred meals each Saturday. GAAP, our food pantry, provides groceries to at least 80 families, and our clothes closet provides clothing to people who need it. About a dozen volunteers make much of this happen each week, and the majority of those volunteers are not members of O’Neal Street.

Our ministry also responds to needs throughout the year. When winter temperatures become dangerously cold, we open our building as an overnight shelter and warming center. During extreme summer heat, we provide a daytime cooling center. In the summer, we open the church for a reading camp for children.

Our community men’s group also holds two chicken stew fundraisers each year, with the proceeds going back into helping people in the community.

We are proud of these ministries because they have grown out of a simple question: What does our community need, and how can we help? Sometimes that means sitting down with one person and helping them look for a job or connect with social services. Other times it means larger ministries like GAAP or Feed Thy Neighbor. Whatever the need, the heart of it is the same. It is about building relationships, knowing our neighbors and being present with one another.

3. What’s the biggest challenge facing your congregation right now, and how are you addressing it?

Our biggest challenge is growing our worshiping congregation and developing the next generation who will carry the church and its ministries forward.

We recognize the realities of being a small, older congregation. At the same time, there is a much larger community connected to O’Neal Street through volunteering, outreach and community partnerships. That gives us both a challenge and an opportunity.

We are working to deepen relationships with the people around us while becoming more intentional about reaching our neighborhood. We do not simply want more people in the pews. We want people to discover a community where they can worship, serve, grow and belong.

4. How has your church navigated the broader changes happening across the United Methodist denomination in recent years?

We have tried to navigate the changes in the UMC by embracing what I believe is one of the strengths of our Wesleyan tradition: We have a wide umbrella.

The people at O’Neal Street have always had theological, political and social disagreements with one another. Many of the people here are longtime friends who have no problem voicing their thoughts, but they are also really good at listening to one another. They can disagree and still worship together, serve together, laugh together and care deeply for one another. It truly is a place where people are accepted for who they are, no matter where they are in life.

5. If you could tell the rest of South Carolina one thing about your corner of the state, what would it be?

There is real need in our community, but there is also tremendous generosity. We see people from different churches, civic organizations, colleges and walks of life working beside one another to care for their neighbors. Many have no formal connection to O’Neal Street. They simply see something that needs to be done and show up to help.

Our corner of South Carolina reminds us that a small congregation can help create something much larger than itself. You do not have to have unlimited people or resources to make a difference. Sometimes you simply need to open your doors, build relationships, share what you have and give people a place to serve.

Herbert may be little, but he knows a great big secret: hurdles aren’t stop signs—they’re chances to grow. With persistence, determination and good old grit, Herbert reminds us that we can do hard things, that our first try doesn’t have to be perfect and that asking for help is always okay.

Cook is an enthusiastic supporter of children and boosting their self-confidence. She has worked with and taught children for more than 25 years in churches, preschools and at Epworth Children’s Home. Meg



is a daughter, a United Methodist Church pastor, a certified Christian educator, a puppeteer, a gluten-free baker, a wife and a mom to two energetic, super-smart boys. She lives with her family in South Carolina and currently pastors Grace United Methodist Church, Columbia.

The surprising soul-
comfort of change

Last week my husband and I took our first “empty nest” trip together after our daughter left for college. Driving through the Blue Ridge Mountains, we decided it would be a nice idea to stop by the spot where we had sprinkled my dad’s remains six years ago.

However, while I had pinned the spot on my iPhone map, I never wrote down the exact coordinates, and my phone had updated and somehow lost the pin over the years. Still, we managed to find the trail by memory and began to make our way along the wooded and brambly path. We reached the river and turned right, going up the ridge. I’d wanted to sprinkle his ashes overlooking a river, but not too close that it contaminated the water, so we had a rough idea of where we were going. I even had a picture of the spot where I’d placed a tiny painted rock, there in this picturesque location that I know would’ve made my dad happy.

Yet six years had vastly changed what had seemed like a timeless, unchanging landscape. Between winters and runoff and Hurricane Helene, the spot was familiar, yet not the same. Large rocks and downed logs now blocked the path, and in its place a new path had been blazed. The river, while still breathtakingly beautiful, now boasted massive timber and boulders where none had been before.

It was the same location, yet so much had changed.

Instead of dismay that I had not found the exact location where we had sprinkled my dad’s ashes six long years ago, a deep feeling of comfort arose within me.

For my soul understood what we all know inherently—everything changes. Nothing on this earth is permanent, even nature. While the sun still rises and sets and the mountain still stands, every day brings different terrain. The mountain changes. It’s still beautiful, still peaceful, but it’s different. It’s new. And that’s not a bad thing.

Eventually that mountain, too, will crumble. I imagine one day the sun will no longer rise and set when our Lord and Savior returns and ushers in a new heaven and a new earth.

Only God—Father, Son and Spirit, three in one—remains everlasting, and we who believe in and follow him are everlasting because we are a part of him.

Right now is a time of change in my life. Our youngest daughter has now gone off to college, and other than my stepson who comes over every other weekend, we are empty nesters. Parents are aging, beloved relatives and friends pass away and even our denominational structure is changing. None of this is a bad thing. It’s simply a new opportunity for God’s glory and beauty to shine—a new mode of expression, a new path in the wild.

As I stood there on that altered ridge overlooking the river rushing below, my soul settled anew. Gone was the rock that had marked my father’s remains; gone was the path I stood upon six years ago.

Yet the same God still stood right there with me, holding my hand. And all was well.

Listening art or skill

I invite you into a series of what-if questions around listening. Is listening an art or a skill? When was the last time you actually listened with all your senses? Have you ever listened with all your heart, mind and soul?

I think listening is both a skill and an art. Listening has been defined as a skill that involves active processing and reflection. Listening as art requires empathy, humility and the willingness to create sacred space for other voices and all of creation to express themselves without judgment, interruption or initial interruption of their feelings and thoughts. I believe this kind of listening build trust.

Take time to truly listen to another and you might hear the voice of God. I encourage each of us to listen for God’s voice everywhere. We could use a bit more listening these days in our public and political discourse. In a world where the loudest voice seems to get most of the attention, and constant chatter distracts us from recognizing the voice of Jesus, there is need of listening as both art and skill.

What if God’s voice is the still, small voice that speaks as it did to Elijah? God does not speak in the fire, the earthquake or the mighty wind but through a quiet, gentle whisper. A season of holy listening might open ears so that we might hear the voices we need to

hear but have ignored, the voices buried beneath the barrage of words written and heard on social media post, blogs, network cable news and podcasts.

I like the words Marilyn McEntyre uses when she writes, “Listen for God’s voice everywhere. And don’t forget that the Spirit may use the people who annoy you to teach you. Precisely the word we need may come from a sullen 19-year-old with a nose ring, or from the bore who corners you at a party or from an officious neighbor.”

I often ask myself the following questions. Where have I missed hearing the voice of God? Where have I missed God’s voice because I have been distracted? Where have I missed God’s voice by filling up the space with my words instead of God’s word? What if we listened beyond our resistances and prejudices?

What if we practiced the skill and art of listening? It may lead us beyond our assumptions and divisions. It might change our religious, political and public discourse.

Whenever it was my turn to lead preschool chapel as a pastor, I would always tell the kids to put their listening ears on. Let’s put our spiritual listening ears on today, remembering God speaks to us in a million voices and in all creation.

Those who have ears to hear, let them hear.

The neighbor who teaches us

There is a subtle temptation in the church to believe we are the ones who bring what others lack. The longer I serve as a prison chaplain, however, the more I realize how incomplete that posture can be.

Some of my greatest teachers live behind the fence. They have taught me that good neighboring begins with humility—the willingness to believe there is something to receive from the person standing before us.

When we assume we understand someone because of their circumstances, we stop listening. When we reduce a person to a label, socioeconomic status or criminal conviction, we quietly move from seeing a neighbor to seeing a project. Jesus understood this. When asked, “Who is my neighbor?” He did not provide a list. He told the story of the Good Samaritan and challenged his listeners to reconsider what it means to be a neighbor.

Our churches sincerely want to serve. We create outreach ministries, distribute food, support reentry, build partnerships and advocate for people experiencing hardship.

But good intentions do not automatically produce good neighboring. Sometimes our desire to help moves faster than our willingness to listen.

Before creating a ministry, listen to the people it is intended to serve. Before deciding what a community needs, ask what the community says it needs. Before measuring success by what we provide, ask whether trust is being built. And before assuming the church has the answer, make room for the possibility that our neighbors have something to teach us.

This does not mean abandoning accountability or justice. The people I encounter in prison have caused real harm, and accountability matters. But accountability and dignity are not opposites. A person’s past does not erase the image of God they bear.

The person returning home after incarceration may teach us about restoration. The young person who has stopped attending church may teach us what the church has failed to hear. The community we have been trying to “reach” may teach us that what it really needs is not another program, but a partner.

Perhaps faithful outreach begins when we stop asking only, “What can we do for them?” and start asking, “What can we learn from them? What can we build together?”

That shift changes how we design ministries, who gets invited into the conversation and how we define success.

If your church is rethinking its approach to outreach, advocacy or reentry, begin with three questions: Who are we serving? Have we listened to them? Are we building with them—or simply doing for them?

These questions can transform more than a program. They can transform the relationship between a church and the community it hopes to serve.

The church has an extraordinary opportunity to move beyond good intentions toward more thoughtful, relational and sustainable ministry. That work requires more than compassion. It requires listening, partnership and a willingness to examine whether the ways we serve are actually helping people flourish. Because perhaps the goal is not simply to help our neighbors but to become better neighbors.

Sometimes, the neighbor we thought we came to serve becomes the neighbor who teaches us how to love.

Come sit awhile: Rediscovering the lost art of the porch

Come sit awhile.

And I mean awhile, because if you've ever sat on a porch with the right people, you already know there is no such thing as a five-minute conversation. You might have only stopped by to say hello, but somehow an hour later you're still sitting there, you've been offered something to eat, you know what's going on with three different families and somebody has brought up a story that happened before you were even born.

That's a porch conversation.

And lately, I've been thinking that we need those conversations again.

When I was younger and lived in Camden, I used to go to my neighbors' house all the time. We would cook, eat together, sit around, talk, laugh and just spend time together. There didn't have to be an occasion. Nobody needed to send out invitations. Nobody had to make a Facebook event. You just went over there.

And let's be clear: when I say we talked, I mean we talked.

Porch conversations can start with, "What are y'all cooking?" and somehow end with somebody telling you what happened at church 15 years ago. There is no agenda. The conversation just goes wherever it decides to go.

Looking back, though, those ordinary moments meant something.

I think about my great-aunt's house, too. She had a sunroom that was almost like her version of a porch. It had sliding glass doors all around it and plants everywhere, and we could sit there and watch the cars go by.

Now, watching cars drive down the road does not exactly sound like premium entertainment. But somehow it was.

We would sit there and talk. A car would pass. We'd talk some more. Another car would pass. And depending on who was sitting in that room, there was probably going to be some commentary about that car, too.

And I miss that. Not necessarily watching random cars go down the road—I can still do that. I miss what those spaces created.

They gave us time. Time to laugh. Time to tell stories. Time to hear things about our families. Time to ask questions. Time to eat together. Time to find out things you probably weren't even trying to find out.

And somewhere in all that talking, faith had a way of showing up, too.

That's something I've started noticing about faith: some of the conversations that stick with you don't happen during a sermon.

Sometimes they happen while somebody is fixing a plate.

Sometimes it's an older person telling you about something they went through and how God brought them through it.

Sometimes it's somebody giving you advice you absolutely did not ask for—but years later you realize they might've had a point.

Don't tell them I said that.

The Bible actually gives us a picture of faith happening in ordinary spaces. Acts 2:46 describes believers spending time to-

gether and sharing meals in their homes. They worshiped together, yes, but they also lived life together.

And I wonder if we've gotten so busy trying to create community that we've forgotten how simple community can be.

Everything doesn't need a committee. Everything doesn't need a program.

And Lord knows everything does not need another Zoom meeting. Sometimes we just need somewhere to sit.

Because somewhere along the way, life got fast.

We text instead of stopping by. We scroll while we're eating. Everybody has somewhere to be, something to do, something to finish or something buzzing in their pocket.

And no, I'm not about to tell you to throw your phone away. Mine isn't going anywhere, either. I'm just wondering whether we've made enough room to actually talk to one another.

Maybe churches need some porch conversations again.

Not another meeting where everybody sits around a table staring at an agenda.

I'm talking about conversations where young people can sit with older people and actually hear their stories. Where older people can hear what's happening in our lives too. Where nobody has to have the perfect answer. Where we can laugh, disagree, eat something good, talk about life and somewhere in the middle of all of it talk about God.

And here's what I've realized:

The porch doesn't even have to be a porch.

For my great-aunt, it was that sunroom with the sliding glass doors and the plants. For somebody else, it might be the kitchen table.

It might be the barbershop.

It might be somebody's living room.

And for church folks, apparently it can be the church parking lot, because we can say we're leaving after service and then stand beside somebody's car talking for another 45 minutes.

You know it's true, I'm PK and was a church baby before that, I know—trust me. But maybe that's what we need to rediscover.

Not the porch itself, but what the porch gave us. Presence. Conversation. Community. A place where faith wasn't always preached at you but sometimes simply shared with you.

So this September, as the weather starts changing and hopefully South Carolina finally decides we've suffered through enough heat, maybe pull up a chair.

Call somebody over. Fix something to eat. Put the phone down for a little while. And just talk.

You never know what you'll learn, what you'll laugh about or where the conversation might go. Just don't say you're only staying five minutes. We both know better. So come sit awhile.

A different conversation about awakening

Recently, I found myself exploring a rabbit hole. It began with the story of the Watchers, the Nephilim and the Book of Enoch before moving into conversations about the "Divine Spark." While I do not subscribe to many of the conclusions associated with these ideas, I found myself asking a different question: Why do they resonate with so many people?

The more I reflected, the more I realized the issue is not angels, giants or hidden knowledge. The conversation is about identity. Who are we? Who told us who we are? Whose voice do we trust? Perhaps that is where the church should begin—not by asking whether people are searching, but what they are searching for.

As Christians, we reject the idea that human beings are divine or that salvation comes through secret knowledge. Yet before dismissing these ideas, we should ask why they resonate with so many people. I suspect people are searching for freedom from false identities. They long to believe they are more than their failures, fears and the labels placed upon them.

That question is important to me as a Black pastor serving in South Carolina. I suspect many African Americans in our churches are descendants of enslaved people. For generations, they were told they were less intelligent, less capable, less valuable and less deserving. Entire systems reinforced those lies, and portions of Christianity were sometimes used to support them. Yet when enslaved Africans and their descendants opened the Bible for themselves, they discovered another story. They found Moses confronting Pharaoh, Israel walking out of bondage, prophets speaking truth to power and Jesus proclaiming good news to the poor and freedom for the oppressed.

Most importantly, they discovered they were created in the image of God.

That discovery helped build the Black Church. The Black Church did not survive because it convinced people they were worthless sinners. It survived because it reminded people they belonged to God. It proclaimed they were more than what the plantation called them, more than what society labeled them and more than the limitations imposed upon them. The message was not perfection. The message was God-given worth and dignity that no person, institution or system could take away.

That witness still has something to teach the church as we seek to speak hope into a generation wrestling with identity and belonging.

Christianity reminds us that identity is discovered through our

relationship with God and one another. Jesus met people where they were: fishermen, women from all walks of life, the sick, the poor, the rich and marginalized people.

If Jesus walked through our communities today, I imagine he would sit with us at our kitchen tables, listen on our front porches and gather strangers beneath the shade of a big tree. In each encounter, Jesus restored people to community and helped them find their voices. That understanding of community remains one of Christianity's greatest strengths.

John Wesley spoke of God's grace already at work in our lives. Howard Thurman explored faith for people whose backs were against the wall. Martin Luther King Jr. reminded us that faith must shape personal transformation and social responsibility, while Jarena Lee demonstrated what it meant to answer God's call even when others tried to silence her voice. Their witness reminds us the body of Christ is enriched when we listen to one another's stories.

The South Carolina Conference of The United Methodist Church is becoming increasingly diverse, and I believe that diversity is a gift rather than a problem to solve. Different communities ask different questions because of different stories and experiences. Instead of fearing those differences, we should welcome them as opportunities to deepen our understanding of the gospel and one another.

In the end, I am less interested in debating theories about hidden knowledge or ancient conspiracies than I am in asking what makes them attractive. I believe people are searching for what the church needs to revisit: we are created by God, loved by God and called by God. We are more than our failures, fears and society's labels.

Perhaps that is the conversation we need in this season. Not a conversation about secret knowledge, but about sacred worth. Not a conversation about hidden bloodlines, but about the image of God. Not a conversation about escaping our humanity, but about embracing who God created us to be.

That is my appeal to our conference. Let us become a people willing to listen rather than label, willing to understand rather than assume and willing to recognize the image of God in one another before focusing on the differences that separate us.

Making room for one another's stories makes God's grace more evident. That is not a conspiracy. It is the Gospel.

Caregiving rewarding,
but stressful

Taking care of a loved one is one of the greatest expressions of love anyone can make. Caretaking expresses agape love, the love that puts the interest of the other person over self. When we think of caregiving, we most often think of a spouse caring for their partner or an adult child caring for an aging parent. However, caregiving may take many forms.

We usually think of caregiving taking place in the home, but caregiving also takes place in a facility. The family members may not do the hands-on caregiving, but they provide emotional support for their loved ones. They also provide care by attending care team meetings and making sure that the care is carried out. They take on financial responsibility, making sure the bills, especially the insurance, are paid.

Even if one is not with their family members on a day-to-day basis, they still may be a caregiver. They may take on financial responsibilities, allowing the caregiving family members to focus on care. A distance caregiver may come to give care periodically to give the primary caregiver some respite.

We usually think of caregiving as a long-term endeavor, but it may be short-term, such as with someone going through cancer treatment. Also, we consider caregiving to be for a physical condition, but one may be a caregiver for a loved one who is mentally ill or intellectually challenged.

While caregiving is very rewarding, it is also very stressful. Caregiving takes a lot of time—time that is taken away from others. Caregivers may miss events in a child’s growing up because they are caring for a parent. Many caregivers are sandwiched between taking care of aging parents and raising children. Caregiving also takes away time from hobbies and social activities.

Caregiving may also be a financial burden. There are costs for travel, unless the person lives in the home. There are costs for medicines, dietary supplies and other supplies that insurance may not cover. There may be the burden of budgeting for two households.

A caregiver will face many difficult decisions: “How long will the money hold out?” “When will I need to call for hospice or other agency help?” “What is the person’s end of life wishes and can I carry them out?” “When will I know to ask to stop treatment?” These are just a few of the questions and decisions a caregiver must face.

Caregiving may become very isolating. The caregiver may not have time and energy to engage in previous social activities. Instead of attending church, they may view online services or watch on television. They may lose their sense of self. Their identity may become enmeshed with the role and the person they care for. Many caregivers may feel that they are alone.

How can the church respond to the needs of caregivers? The church may want to start a caregiver group. The church may partner with agencies that have expertise to provide support for care givers.

At St John’s United Methodist Church in Lugoff, we have partnered with MUSC hospice to provide a caregiver support group. The caregiver support group meets every second Monday of the month from 2-4 p.m. This is a time for learning, sharing and fellowship with other caregivers.

Some churches may have social hours for caregiver support. Community agencies may offer caregiver support, in some cases for specific situations such as dementia.

Pastors and visitation teams should take time to talk to caregivers when visiting sick and homebound parishioners. A few minutes of time for a caregiver to vent and prayer for the caregiver can go a long way in letting the caregiver know they are not alone.

Caregiving is rewarding but stressful. May we always be aware of caregivers in our congregations and do all we can to support them.

When the crowd gets loud, Christ is louder

This being the beginning of the school year, the Lord led me to share another sermonette on bullying and peer pressure, as it has become a very serious problem in schools across this country.

Being a teenager today is not easy. The hallway can feel like a battlefield, the phone can feel like a courtroom and one cruel comment online can become a wound. Bullying and peer pressure are not “little things.” They can bruise the spirit, shake confidence and tempt young people to become someone God has never called them to be.

Romans 12:2 (NIV) speaks clearly: “Do not conform to the pattern of this world, but be transformed by the renewing of your mind. Then you will be able to test and approve what God’s will is—his good, pleasing and perfect will.” The world says, “Fit in.” Christ says, “Stand firm.” The world says, “Get revenge.” Christ says, “Overcome evil with good.” The world says, “Everybody is doing it.” However, Christ says, “Follow me.”

To every teen: You do not have to laugh at wrong just to be accepted. You do not have to join gossip, send obscene pictures, mock the lonely, curse to sound grown or compromise your values to keep friends. First Corinthians 15:33 (ESV) says, “Do not be deceived: ‘Bad company ruins good morals.’” If the crowd pulls you away from God, peace, respect and wisdom, that crowd is too expensive!

Let’s be clear: Loving your enemies does not mean giving them permission to abuse you. Jesus said in Matthew 5:44 (ESV), “Love your enemies and pray for those who persecute you.”

Pray for them, refuse to hate them and do not let bitterness build a home in your heart. Still, healthy boundaries are godly. Tell a trusted adult. Save evidence of online bullying. Block harmful people. Walk away from dangerous conversations. Report threats. Choose friends who protect your future, not pressure your weakness.

Parents, listen before you lecture. Watch for changes in mood, sleep, appetite, grades, friendships or online behavior. Pray with your children, not just for them. Teach them that courage is not fighting every battle; sometimes courage is telling the truth, asking for help and refusing to be shaped by fear. Galatians 6:2 (KJV) says, “Bear ye one another’s burdens, and so fulfill the law of Christ.” Our young people should never carry these burdens alone.

Church, family, school and community, we must create safe spaces where young people can speak without shame. A child who feels heard is less likely to feel hopeless.

Young people, when peer pressure knocks, answer with purpose. When bullying tries to label you, remember God already named you beloved, chosen and valuable. Let your mind be renewed, your heart remain guarded and your walk be guided by Christ.

Don’t let the loudest crowd make you forget the holy calling God whispered over your life, and never leave home without Jesus!

NextGEN Worship: Mechanicsville makes room at table

BISHOPVILLE—What happens when a church intentionally makes room for the next generation?

At Mechanicsville United Methodist Church, that question became the beginning of NextGEN Worship.

Born from a desire to bridge the gap between young people and the church, NextGEN Worship was created to provide a space where youth and young adults feel seen, valued and connected to Christ and his church. Too often, younger generations can feel disconnected or unsure of where they fit within the life of the church. Mechanicsville members believed God was calling them to do more than simply invite them through the doors. They wanted to intentionally make room at the table.

Under the vision and leadership of the Rev. Angela Nesbitt Hampton, NextGEN Worship was established as a ministry focused on discipleship, authentic relationships and spiritual growth. While the ministry is geared toward individuals ages 30 and younger, all are welcome to experience NextGEN.

Participants gather every second and fourth Sunday immediately following the morning worship service as they seek to grow together in faith and community. The goal has never been to replace traditional worship but rather to create another pathway for individuals to encounter God, ask questions and grow deeper in their faith journey.

Since its launch on Feb. 9, 2025, NextGEN has become more than a worship service. It has become a community.

They have gathered for Bible studies centered on surrender, forgiveness and spiritual growth. They have shared meals, prayed together during worship nights, created spaces for honest conversations through table talk discussions (“Uncut & Covered”) and encouraged young people to discover they don’t

have to have everything figured out to pursue God wholeheartedly.

Most importantly, they have witnessed God moving in extraordinary ways. Since beginning this journey, 17 youth and young adults have been baptized, 11 individuals have joined the church and seven have publicly given their lives to Christ. These numbers represent more than statistics. They represent transformed lives, answered prayers and God’s faithfulness at work through his people.

Mechanicsville members said one of the greatest blessings of this ministry has been watching individuals become more comfortable engaging with Scripture, participating in conversations about faith and understanding that church is not simply a place we attend, but a community to which we belong.

NextGEN has reminded members that discipleship is intentional work. Young people are not merely the



Since beginning this journey, 17 youth and young adults have been baptized, 11 individuals have joined the church and seven have publicly given their lives to Christ.

Cognitive Care Ministry a way for churches to love neighbors

Disciples of Jesus Christ within the ecumenical church are called to care for one another. Churches spend time and money growing, promoting and nourishing various ministries. Children, youth and young adult ministries are prioritized as the future of the church.

However, we are also called to care for the older members of our churches—the elderly who came before and often built or helped grow the current church in which disciples today worship and fellowship.

Many churches in our annual conference are answering the call to care for the spiritual needs of older church members. For those who suffer from dementia, churches are discovering new ways to walk alongside individuals and the family members who care for

them.

Through the Cognitive Care Ministry of the South Carolina Conference of The United Methodist Church, congregations have an opportunity to turn compassion into meaningful ministry—creating communities where memory loss is better understood and no one has to face the journey alone.

The mission of Cognitive Care Ministry is both practical and deeply rooted in the church’s call to care for one another: to educate congregations about dementia and other forms of cognitive decline, reduce the stigma that often surrounds memory loss and equip churches to support individuals and their family caregivers.

As South Carolina’s population ages, the need for churches to support the elderly and their families also increases.

Churches enjoy a unique space to help this population of the church and community. Those who are dealing with dementia often are unable to attend regular worship services or events at the church. They are isolated from the church, residing in assisted living facilities or homebound. Their families may also have less time to participate in the life of the church but do not voice their needs. A population is suffering in silence.

Therefore, the Cognitive Care Ministry encourages churches to recognize those challenges and ask an important question: How can we continue to be the church for these individuals and families?

The answer does not have to begin with a large program or a large budget. It can begin with education, awareness and a congregation willing to learn.

Churches across South Carolina are already exploring different approaches. Ministries can include educational seminars, caregiver support, fellowship opportunities, dementia-friendly worship and activities, and respite programs that provide meaningful engagement for adults experiencing memory loss while giving their caregivers valuable time to rest, attend appointments or simply take care of everyday needs.

Education is an important part of this ministry because dementia affects more than memory. When church members understand what a person with cognitive impairment is experiencing, they are better prepared to respond with patience, dignity and grace.

Training opportunities, including “Dementia 101” workshops offered in partnership with organizations such as the South Carolina Department on Aging, can help congregations understand dementia and consider practical ways

their churches can respond.

Regional workshops hosted at United Methodist churches also give clergy, church staff, lay leaders and volunteers opportunities to learn from one another and explore what a cognitive care ministry might look like in their own congregation.

Plans are under way to develop an annual conference database of cognitive care ministries in local United Methodist churches here in South Carolina. This resource will help identify congregations already offering dementia-related ministries and make it easier for churches, families and ministry leaders to find programs and connect with one another. There will also be connections to other cognitive care related ministries or opportunities in other non-United Methodist churches and secular programs.

The database can also help churches learn from ministries that are already established. A congregation interested in beginning a caregiver group, respite ministry or educational program will be able to see where similar work is taking place and connect with people who have experience.

Additional information is also coming about cognitive care ministry opportunities throughout South Carolina, including training events, educational resources, workshops, ministry models and ways for churches to become involved.

At its heart, the Cognitive Care Ministry is a ministry of presence alongside one another as the gathered body of Jesus Christ.

Quilts of Valor awarded to veterans at Travelers Rest UMC

TRAVELERS REST—The Swamp Rabbit Quilt Guild and Travelers Rest United Methodist Church hosted a Quilts of Valor service Aug. 13.

The service honored seven church members who had served in the Armed Forces. The recipients for this year served a cumulative 68 years in the Army, Air Force and Navy.

The Quilts of Valor Foundation began in 2003 as part of a mother’s dream to wrap quilts made with love around the shoulders of veterans who may be suffering untold memories from their years of service. Today, more than 450,000 quilts have been wrapped around men and women who have served in the U.S. Armed Forces.

Rita Cossio, deployed to Iraq as a 57-year-old reservist, shared her touching story as the keynote speaker. The veteran with 40 years of service told the crowd how a woman she didn’t even know wrote her letters of encouragement on a daily basis while she served in Iraq. Years later, the two were able to meet face to face when this same woman presented a quilt she had made specifically for Cossio and wrapped it around her.

Each quilt is handmade by volunteers and may have anywhere from 50 to 80 hours invested in its piecing, quilting and binding. A label is sewn to the back naming the specific veteran being honored and the volunteers who contributed their time.

During the service, names of each veteran were called. The quilt was held up for display, and then quilters wrapped it around the shoulders of the veteran.

Certificates were then awarded by three-time

The quilts for this year’s service were made by members of the Swamp Rabbit Quilt Guild, an organization of more than 54 members. This group meets twice a month, using the TRUMC facilities for lectures, sewing and fellowship. The group first formed in 2009 and is made up of both church and community members. New members are always welcomed.

When asked about the guild’s activities, President Sandy Bailey said, “It has been an honor, and pleasure, to work with and lead this group of talented ladies for the past two years. However, an even greater privilege has been for our guild to honor local veterans with a quilt through the Quilts of Valor Founda-

tion. Each one is made with much love and care.”

During worship services the previous Sunday, Senior Pastor Brian Gilmer called attention to the seven quilts draped across the altar rail as a part of sharing the beauty of these pieces of art with the entire congregation. He recognized the quilt guild for the 350-plus hours their volunteers put into the project.

Of those being honored this year were a 93-year-old father and his daughter who both served in the army—he served three years and she served 30.

This was the second year for the service to be held at TRUMC. Veterans are nominated by family or friends through the Quilts of Valor Foundation and do not have to be members of the church.

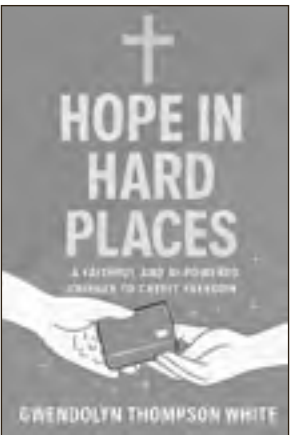

One family enjoys a combined 60 years of Salkehatchie service

In the summer of 1985, a family of five packed up their nine years of belongings and memories and moved from Stone Mountain, Georgia, to Columbia.

Their Salkehatchie story began as they searched for a church. After visiting several, they had one more to visit. One August Sunday, they went to Ashland United Methodist Church. The sermon time sealed it for them—this was the church for them. And to top it all off, the pastor did not preach that day. Instead, Salkehatchie youth gave testimonies of their Salkehatchie weeks in different parts of the state.

With children who were, 7, 10 and 13, these parents realized this is what they wanted for their children, and they joined Ashland without hearing the preacher preach!

About two years later, a member of Ashland asked the oldest daughter if she would go to Salkehatchie in his son’s place who had paid was unable to go. She went to a Salkehatchie camp between Georgetown and Pawley’s Island. Three years later, the second Harrelson daughter went to her first Salkehatchie camp, and three years later the son went to his first.

The two girls also went to the college Salkehatchie camps held in early May so college students could work one before beginning summer jobs.

Now grown, today the son, Robert, has been involved as a Salkehatchie camper for 30 years. He now leads the Winyah Bay Salkehatchie camp in Georgetown and has done so for four years. He and his wife spent their first anniversary working a Salkehatchie camp. She worked at the camp with him until their children were born.

When their children came of age, they each joined their dad at Winyah Bay Salkehatchie. Mom’s church circle began making goodie bags to put on the campers’ pillows midweek every summer.

The middle daughter had two sons. When the oldest turned 14, he followed in his mother’s footsteps and went to Salkehatchie. His younger brother joined him when he turned 14.

This summer at the Winyah Bay Salkehatchie, 10 Harrelsons were involved—Robert Harrelson as camp director, along with his wife; all three of his children (ages 20, 18 and a first-time 14-year-old); Robert’s two nephews, ages 19 and 15, who are members with their parents of Shandon UMC, Columbia; and his parents and his Georgetown uncle cooking one of the nighttime meals.

And it all began that Sunday in 1985 when young Salkehatchie missionaries spoke in a church in Columbia.

Together, the family has more than 60 years of combined service with Salkehatchie.

“The SEJ Conference exemplifies the Holy Spirit’s influence in guiding us toward the realization that we are stronger together, interdependent, and that hope prevails.”

Former South Carolina Bishop L. Jonathan Holston, now bishop of the Alabama-West Florida and North Alabama conferences, presided over the called session, which was held virtually.

“Wow—wow,” Holston said after the vote of 291-0.

Bishop Robin Dease, episcopal leader for both Georgia conferences,

offered a prayer after the vote.

“Holy God, we give thanks for these delegates who have cast votes to approve unification,” she prayed. “As this decision now becomes a part of our shared story, turn our hearts upon the future you are preparing for us,” she continued. “Make this unification more than just an administrative change, O God, but make it a holy opportunity to deepen our commitment, to widen our welcome and to strengthen our ministries, so that lives might be transformed for your kingdom’s sake.”

The combined conference will have more than 215,000 members.

Scott Cleaveland, South Georgia Conference’s lay leader, and Kim

Powell, North Georgia Conference lay leader, jointly presented the motion to unite to the Southeastern Jurisdictional Conference.

After the vote, the SEJ Committee on Episcopacy gave a report on preparation for the 2028 Jurisdictional Conference, which is slated for July 12-15, 2028, at Lake Junaluska, North Carolina. The COE said that the SEJ is

the largest jurisdiction in the United States and is seeking nine bishops in 2028 (compared to six sought in the Northeastern Jurisdiction, seven in the North Central Jurisdiction, seven in the South Central Jurisdiction and five in the Western Jurisdiction).

Given planned retirements, SEJ will be electing five bishops in 2028; four SEJ bishops will continue.

Payne said the destruction brought back difficult memories from his time doing search and recovery in the Air Force.

“It was eye-opening to me—I was sitting on a stool Sunday morning, giving my message, and then Tuesday where all those people sat, I’m looking at debris and realizing how blessed we are that this wasn’t 48 hours earlier!” Payne said.

The cause is currently under investigation, and they are waiting now on the structural engineer’s report. Both the fire department and a structural engineer told Payne the collapse was not related to water damage.

“The adjuster from insurance scratched his head and said he’d never seen anything like this,” Payne said.

For now, the congregation is worshipping in their fellowship hall, and they even managed to host vacation Bible school in spite of the collapse. But that, too, is a difficulty—they lost an air conditioning unit in their fellowship hall in mid-August and are awaiting repair quotes on that as of press time.

Payne said the timing of these setbacks has been discouraging, both to him and to the congregation. They had just reintroduced a children’s Sunday school class in July when the ceiling collapsed. They also don’t know right now if they will be able to reuse their hymnals and pew Bibles because everything is covered with fiberglass and debris from the ceiling.

“Right now we’ll continue pressing on, we’ve got plenty of space to worship, but it can really drive a dagger in the heart because we were beginning to move forward and then this happens.”

Many took to social media to express lament, as well as gratitude that the destruction wasn’t worse.

William Wood said God was surely holding the ceiling from falling that Sunday.

“God blessed the people of Brookland Sunday morning, amen. Praying for our church,” he shared.

Robbie Hughes Lynch shared that she grew up at Brookland and was married there.

“This makes me sad,” she posted. “Praise God no one was injured.”

Payne said they are hoping South Carolina United Methodists will lift up

prayers of encouragement for them as they await repairs. There is no word yet on whether insurance will cover the damage.

What was especially hard for Payne was that the destruction brought back memories from his 22 years in the Air Force, where he did search and recovery to retrieve fallen service-members. The work included going into destroyed buildings in Turkey and Afghanistan and removing people.

“I’m not used to seeing that in church. It was devastating, and it triggers you—it brings back some stuff that I witnessed,” Payne said.

Still, he knows God walks with them during this time.

“In Jeremiah 29:10-14, Israel was captive in Babylon, and God said, ‘You’re going to be bigger and better; I know what I have planned for you. It’s not over,’” Payne said.

He and his flock are holding onto that, praying hard and pressing on.

In April, Orozco won the college’s Apex Showcase, a capstone project presentation that is the culmination of the college’s signature professional development concentration, which is earned by all bachelor’s degree students. As the student speaker, Orozco also received the Yandle Class Leader Award.

“SMC didn’t just give us an education; it gave us a community where we grew into ourselves,” said Orozco in her speech. “Our professors didn’t just teach us; they connected with us. To the graduating class, choose connection; choose compassion. Reach out to your community—not just when you need to, but when they need you.”

The ceremony also included the awarding of SMC’s first honorary degree. Jill Johnson, the college’s long-serving registrar and a 1982 associate degree graduate, received an honorary Bachelor of Arts degree in recognition of 41 years of service to SMC and its students. Johnson completed her bachelor’s and master’s degrees at other institutions because SMC did not award bachelor’s degrees until 2019.

Claflin University celebrates new era of STEM Education

ORANGEBURG—Claflin University’s STEM Agenda is a strategic effort to enhance Science, Technology, Engineering and Mathematics education to

build a future-ready workforce through innovation in both the classroom and research.

The groundbreaking ceremony for

the new Center for Biotechnology and Innovation, held March 20, represents a historic milestone in Claflin’s STEM legacy.

The Center for Biotechnology and Innovation will expand faculty and student research. Students will receive hands-on experience with advanced technology that will transform in-class and online pedagogy. Claflin STEM graduates will be even more prepared for leadership positions in the fast-paced tech industry.

The two-story facility will encompass nearly 32,000 sq. ft. and sit between Magnolia Street and Goff Avenue. A portion of the building’s footprint will cover what was formerly Dunwalton, the official residence of Claflin presidents.

Dr. Dwaun J. Warmack, Claflin’s ninth president, said the groundbreaking ceremony was historic because in 1971–55 years ago—Dunwalton became the official residence for Claflin’s presidents.

“But it was not always the presi-

dent’s home,” Warmack said. “Prior to 1971, the president’s residence was located at the present site of the James S. Thomas Science Center (JST).

However, the president and board of trustees recognized that a new facility was necessary to enable the University to recruit and retain talented STEM students.

That led to the decision to tear down the president’s residence and build the James S. Thomas Science Center and Dunwalton as the new presidential residence.

Claflin was the first historically Black college/university to receive NIST-Construction funding.

The center will be the new home for Claflin’s biotechnology, computer science, computer engineering and cybersecurity programs.

The facility will feature advanced specialized labs for biotechnology, cybersecurity, artificial intelligence and robotics, as well as flexible space classrooms, 3D printing, and rapid prototyping.

Connecting Children.

Every generation belongs: Ways to grow

Across the South Carolina Conference, congregations are discovering what happens when children, youth and adults stop sitting on separate sidelines of the faith journey and start growing together.

That vision is at the heart of “Connecting Children in Worship and Prayer,” the Conference’s Lilly Endowment-funded initiative, and this summer’s stories from cohort churches show just how far that vision can travel.

At Orange Grove United Methodist Church, vacation Bible school became a “Trip of a Lifetime.” The sanctuary was transformed into an airport, and children, youth and adults boarded together for three flights of faith: a Faith Flight built on Matthew 14, a Love Flight grounded in 1 John 4 and a Prayer Flight drawn from Philippians 4. Every participant, regardless of age, carried a passport and a handmade suitcase to collect what they learned along the way. Pastor Sheera Yates and the Orange Grove family credit the week’s success to the whole body of Christ boarding the journey side by side.

In Columbia, Grace UMC took a different route to the same destination. After Messy Church training, the Rev. Meg Sweeney Cook and her congregation asked a simple question: What if VBS wasn’t just for children? Two years and two Messy Church VBS experiences later—Joy in the Mess and this summer’s Taste and See—Grace has built an intergenerational model rooted in hospitality, creativity, celebration and shared experience. Momentum is building beyond Grace, too: On Aug. 1, Dr. Johannah Myers led Cohort 2 congregations in Messy Church training at Epworth in Columbia, equipping even more churches to try this approach.

These stories are exactly why “Connecting Children in Worship and Prayer” continues to matter. For congregations feeling the strain of disconnected generations or declining children’s participation, this initiative isn’t “one more program”—it’s a way to align worship and discipleship around a shared vision: all generations together, growing in faith in Jesus Christ. Participating churches receive quarterly in-person and online training, access to partner resources like Messy Church USA and Narrative 4, and year-round coaching support.

Mark your calendar for another exciting step in this journey: Dr. Nelson Cowan will be speaking on Oct. 17. Cowan serves as director of the Center for Worship and the Arts at Samford University, and his expertise in designing, planning and evaluating worship experiences made him a natural fit to lead our Q4 quarterly training. He’ll be helping cohort churches think even more intentionally about what it takes to build worship that truly includes every generation. More details coming soon.

About the impact of Native American Industrial Schools

Many people have heard about Native American Boarding Schools. More than likely they actually know the name of these schools: Native American Industrial Schools in the United States.

Natives who attended these schools were taught to become domestic help or learn different trades during their residency there. The schools rented out the children to different wealthy households in the area. Other duties or occupations changed, with some even becoming teachers.

The first industrial school was opened in October 1879 in Carlisle,

Pennsylvania. The last two were opened in Bismarck, North Dakota, in February and December 1908. At one point there were 400 of these industrial schools.

The last federally run Indian Boarding School in the United States was closed in 1996.

The first boarding school was the Carlisle Industrial School. It was founded by Lt. Richard Henry Pratt under the U.S. government’s authorization. Pratt is more famously known for saying, “Kill the Indian, and save the man.” It was based on the so-called idea of civilizing the Natives by making them Christian

and speak only English.

To achieve this goal upon their arrival, the schools forced all the indigenous elements of the children’s culture to be removed. Their hair was cut, and their tribal names were replaced with English names. Their Native clothing was discarded and replaced by uniforms, and the children were forbidden to speak their Native languages. If caught speaking their various tribal languages, severe punishment often resulted. In many cases, it was almost impossible not to speak their Native languages because before arriving at the boarding schools, most did not speak English. It must also be noted that the teachers at the boarding schools spoke both English and another Native languages. This practice of speaking only English was to forcibly indoctrinate the Native children.

In many cases, these children were also forcibly separated from their families, who were by this time living on reservations, so the children were more easily rounded up and taken to boarding schools. It has been recorded that, while attending Carlisle, almost 200 children died from diseases, malnutrition, intentional neglect and other severe causes. Some of these children were buried in unmarked graves.

A federal investigation in 2024 discovered at least 973 children died while at the federally funded Indian boarding schools. However, the exact numbers will never be known because the schools sent many of the children back

home once they became ill.

Recently there have been efforts to return the remains of these children to their tribal relatives. However, because of some being moved from one gravesite to another during construction of a military museum on the site at Carlisle, records have been lost providing the children’s names and tribal affiliation. It is impossible to know who they are and where they came from. Even with grave markers showing the names of some of these children and their tribal affiliations, there were unforeseen complications when they were to be unearthed. In one such case, five distant relatives of a 10-year-old boy went to Carlisle to retrieve this relative’s remains. When the process to unearth him was begun, they unearthed the remains of a 15 year old girl.

Because of this occurrence, the digging was stopped, and she was reinterned in the spot where she was discovered. It is believed she had been placed on top of the young boy. But no further action has been done to resolve the boy’s issue, at this point, given the many legal complications.

This does not mean that no other investigations are in the works to make sure both of these children can be brought home to their families in the future. It just means more time and new identification processes must take place to make this happen. Hopefully it will happen sooner rather than later. It has been far too long for these Native children.

Kinship Navigation program surrounds kinship caregivers with support, love

In your church or community, you probably know someone who is raising a child who is not their own. Kinship caregivers are typically grandparents, close relatives or family friends who courageously step up to raise a child when the child’s parents are unable to do so. Many kinship caregivers have little or no time to prepare when they first take on this responsibility, and some lack infant or child necessities. Adding to their stress, as many as 30 percent of South Carolina grandparents raising their grandchildren live with a disability, according to the South Carolina Department of Social Services. Twenty-six percent live in poverty.

Child welfare researchers have increasingly recognized the immense value of kinship caregivers. They make it possible for children to remain connected to their families, cultures and communities, which research shows greatly improves child wellbeing.

Two years ago, Epworth launched its Kinship Navigation program, which is aimed at giving kinship caregivers the support they need to give the children in their care a stable, safe and loving home. The program served 633 caregivers and 794 children in 2025. Epworth staff and other advocates also successfully lobbied for a change to South Carolina laws that would make it easier for grandparents and relatives to become eligible to be licensed as kinship foster parents.

Throughout the year, Epworth’s Kinship program provides services and goods at no charge to kinship caregivers. The services include one-on-one case management, guidance on legal and financial matters, referrals to other organizations that can

help families, free notary, copying and scanning services, peer support groups and emotional and mental health support. The kinship program provides access to diapers, children’s clothing, food, school supplies and household essentials. The program also hosts monthly recreational get-togethers for kinship caregivers and their children and discussion groups that give kinship caregivers a chance to share their challenges with each other.

According to SCDSS, approximately 6 percent of all the children in South Carolina live in a home with relatives but no birth parent present.

Epworth is working to spread the word about its kinship program and is asking that churches help by telling the kinship caregivers in their congregations that the program is here for them. Many kinship caregivers feel relief when they learn about Epworth’s program because, for the first time, they have an advocate on their side, working diligently to get them the help they need.

Another way churches can help the kinship program is to hold diaper drives or supply drives to collect household cleaning and laundry products or new bed linens. Epworth also asks that churches provide occasional Parents Night Out babysitting at their church to help kinship caregivers in their community enjoy a little time to themselves.

Duke Divinity is one of 13 United Methodist seminaries in the U.S. The school has a Centennial Preaching Series to mark the occasion, starting with its opening convocation on Aug. 28.

Sponsored by the Tennessee-Western Kentucky Conference, the event attracted Native and non-Native participants seeking to better understand and recover Indigenous skills and stories.

Publisher acquires online journal

DALLAS—Market Square Publishing, publisher of books by United Methodist authors, has acquired United Methodist Insight, a 15-year-old online news-and-views journal covering The United Methodist Church. The transition was announced Aug. 13 by Insight editor and founder Cynthia B. Astle and Market Square Publisher Kevin Slimp.

Conference sues its largest congregation

DALLAS—The Horizon Texas Conference has filed a lawsuit against Highland Park United Methodist Church, arguing changes the megachurch made to its articles of incorporation violate the denomination’s rules for church governance. The conference’s lawsuit says the changes remove both the conference’s oversight and the wider input from the congregation. This is a developing story. UM News will provide updates as available.

Relief reaches hard-hit areas after earthquake

CABANATUAN CITY, Philippines—The United Methodist Church in the Philippines and church partners have provided food, supplies and other support to more than 700 families following a deadly June earthquake and subsequent flooding. Davao Area Bishop Israel M. Painit said pastors and volunteers also have provided spiritual care.

A ‘helping hand’ for detained immigrants

BALDWIN, Mich.—Michigan United Methodists have launched a new ministry, Helping Hands, to reach out to those detained by Immigration and Customs Enforcement at the North Lake Processing Center. The Rev. Cherlyn McKanders and members of Covenant Community United Methodist Church visit immigrants being detained and provide prayer, encouragement and funds for calls home on the processing center’s pay phones.

Agencies launch new monitoring dashboard

GLENVIEW, Ill.—The United Methodist Commission on the Status and Role of Women and the General Council on Finance and Administration announce the launch of a new monitoring dashboard designed to track and report data on clergy status, gender and race across the U.S. connection. “This dashboard empowers our denomination with a clear, honest picture of who is serving in ministry and how that reflects, or fails to reflect, the diversity of the church we are called to be,” said the Rev. Stephanie York Arnold of the Status and Role of Women.

Hamilton wins Democratic Senate primary

LEAWOOD, Kan.—The Rev. Adam Hamilton, founding pastor of the largest United Methodist church in the United States, won the Democratic primary for U.S. Senate in Kansas on Aug. 4. For more than three decades, Hamilton has served as senior pastor at Church of the Resurrection in Leawood. He will challenge Republican U.S. Sen. Roger Marshall in November. “My campaign will bring Kansans together around our shared values and common purpose. Lowering costs. Restoring decency. Ending the chaos and corruption in Washington,” Hamilton said in a Facebook post after securing the nomination.

Deacons take God’s work beyond the church

NASHVILLE, Tenn.—United Methodist deacons serve as bridges connecting The United Methodist Church to the world outside the church. You might find them protesting outside of a county jail, working at a food bank or helping former inmates reintegrate into society. This year marks 30 years since the denomination declared deacons to be a distinct, permanent order of ministry.

Bishop Rapanut to chair Connectional Table

Little River celebrates 150 years

What began as a small mission church in 1876 has grown to become an active congregation dedicated to making disciples of Christ for the transformation of the world.

Little River United Methodist Church has undergone many changes in the last 150 years, but its continued focus on community outreach has set it apart.

“It’s important to celebrate an anniversary like this,” noted the Rev. Tony Adams, the church’s pastor who is beginning his third year leading the church. Throughout Scripture, he said, “God always calls his people to celebrate the milestones.”

He called the celebration an Ebenezer moment—“a physical or spiritual monument reminding us of where we’ve been and the promises that God continues to make in our lives.”

Planning for the anniversary began in the summer of 2025. A committee of about 20 people, led by lay leader Sue Novotny, focused events that would bring together people from the church’s two traditional and one contemporary services.

“We were excited about the fellowship” that combining the services would bring, “allowing members to talk to and get to know other church members they might not otherwise see,” she said.

Beginning in October with a “big tent event” that made use of tents erected for the church’s annual rummage sale, the committee planned other combined services, a family movie night, a Fat Tuesday pancake dinner with special music and a trivia contest with questions garnered from the church building and adjacent graveyard. The grand finale on Nov. 15 will feature a final combined service with special music and a message by South Carolina UMC Resident Bishop Leonard E. Fairley.

True to the United Methodist slogan, “open hearts, open minds, open doors,” Little River UMC has long been involved in serving the surrounding community.

Through its twice-weekly Dignity Ministry, anyone can come, “no questions asked, to have fellowship, have a meal, wash clothes, take a shower and maybe even get a fresh supply of clothes,” said Adams.

Each Friday night, the church’s Shepherd’s Table ministry serves a hot meal—again, no questions asked.

Many ministries of the church are open to anyone in the community. Those interested in playing bells for services, knitting or crocheting prayer shawls, exercising, line dancing, quilting or creating cards have a place in one of the church’s ongoing groups. Many area families participate in vacation Bible school and Trunk or Treat

each year, and the annual rummage sale attracts thousands of bargain hunters to the campus. Since 1983, when few restaurants opened on Thanksgiving, the church has offered a community Thanksgiving dinner, open to all at no charge.

“The church is known in the community for participation in Good News Club at Waterway Elementary School and sharing the good news of Christ with elementary school children,” said Adams.

The church also provides meeting space for Scouts.

The church was once led by the first female pastor in South Carolina Methodism. The Rev. Bessie Parker was the church’s pastor from 1969-1973. While the church has undergone many changes through the years—becoming Methodist in 1885, and moving from one of eight churches in a circuit served by one pastor to one congregation with its own pastor in 1986—one of the biggest changes occurred when the church added a contemporary service.

“Pastor Paul Wood requested that a few of us become involved in creating a contemporary service,” said longtime member Pat Angelini. “We received training from the conference and from visiting other successful contemporary services in the area.”

When the service began, “We sandwiched ourselves between two traditional services, which entailed dragging all the band equipment back and forth.”

With the construction of a large addition in 2009, the contemporary service found a home of its own in a large multipurpose room with a stage for the band, a large kitchen and audio and visual technology for streaming and projecting videos and lyrics.

“It’s an amazing accomplishment—the grace of God that any institution is around for 150 years—and the fact that we’ve been here 150 years says a lot about the faithfulness of the people of Little River,” Adams said.

A history of the Sunday school movement

Sunday school has been with the people of The United Methodist Church since the very beginning.

The concept of Sunday school first began in Great Britain toward the end of the 18th century and was embraced by John Wesley as a way to minister to poor children who worked and only received one day off. The early American Methodists also endorsed the usage of Sunday schools. According to John Schisler in his work “Christian Education in Local Methodist Churches” (Nashville: Abingdon Press, 1969), the minutes from the 1790 annual conferences contain the question, “What can be done to instruct poor children (white or black) to read?” The response to the question was “Let us labour, as the heart and soul of one man, to establish Sunday Schools in, or near the place of public worship.”

The establishment of the early Sunday schools was designed not only for religious education purposes, but was also created to educate children in reading and writing. Bishop Francis Asbury fully supported the Sunday school movement and wrote a pastoral letter to the early Methodists encouraging the adoption of Sunday schools for the instruction of children. By 1798, both Asbury and Bishop Thomas Coke advocated in the *Discipline* for religious education among children, noting that half of the human race was under the age of 16 and encouraged Methodists to teach catechism (Russell E. Richey et al, “The Methodist Experience in America,” Nashville: Abingdon Press 2010, 119-120).

The Sunday schools in local Methodist churches were once described as “the church’s nursery of piety” (Ibid., 120). Many churches around the turn of the 20th century began to construct Sunday school wings and buildings for the advancement of Christian education. An example comes from the history of Bethel United Methodist Church in Chester. The Bethel Church School Annex was constructed in 1926. According to the Rev. A. E. Holler, the congregation on the last day of the fundraising campaign needed \$84.07. A gentleman stepped up on the last Sunday of January 1926 and gave \$85 to pay the remaining amount. When this happened, the congregation began to sing “‘Praise God from Whom All Blessings Flow’ with as much fervor as ever was heard on land or sea” (Ann Pickens Collins, “Wellsprings of Bethel: Memories of the Church and its People,” Columbia: Collins Publications, 1989, 7).

Bethel UMC celebrates this year the centennial of the Church School Annex. Holler’s prayer for the building was, “May it continue through the years to be a blessing to the youth of Chester, a joy to the community, and all to the glory of God.” As a child of Bethel, Holler’s prayer was lived out in my youth.

In a day and age in which many congregations struggle with how to best use empty rooms that once were used for Christian education, times of remembrance and celebration may provide for new visions for God’s kingdom in our midst. Perhaps the question to ask and pray for is not “how will we fill a certain space again with people?” but rather “how will God summon this empty space to be used in a new way?” The empty space may not be used in the same way it once was, but it may become another source of Christian education and formation in a new way. It may become a food pantry, a free medical clinic or an afterschool program for a local public school.

A child may not necessarily receive religious education in the traditional way, but perhaps in the new spaces, a child or youth will learn by example from our congregations the promise of Matthew 25: When we love the least of these, there we find the Lord.

That is a powerful and holy education.

Perfect, permanent high priest

Uniquely Unifying
Lesson Scripture: Hebrews 1:1-14
Background Scripture: Hebrews 1:1-2:4
Key Verse: “The Son is the light of God’s glory and the imprint of God’s being. He maintains everything with his powerful message. After he carried out the cleansing of people from their sins, he sat down at the right side of the highest majesty” (v. 3).

The Book of Hebrews opens with a blast of celebratory, poetic language setting the stage for proclaiming Jesus to be a messenger and representative of God unlike any other. Verses 1-4 offer an overview of how we should view Jesus in contrast to human prophets and divine messengers. Since Jesus participated with God the Father in the creation of all there is, he is to be viewed as having more significance and greater authority than prophets or angels. Both fall short of replicating the brilliance of God the Father. Jesus bears an identical imprint and is an exact representation of God the Father. Jesus joins God the Father in sustaining all creation and is the source of cleansing from inward impurity and sin. Jesus alone is the only prophet and priest who reigns forever because he is one with the Father.

This passage speaks to our two major Christian holidays, Christmas and Easter. We hear the proclamation of Jesus’ birth as the incarnation of a divine deity in human form (verse 6). We hear echoes of Easter in Jesus making or creating a way of purification from our sins on the cross and his triumph over death as he is ascended to the right hand of God the Father (verse 3).

Christians tend to read Hebrews in a manner that demeans and belittles our Jewish roots. We are invited to understand that the Old Testament (Hebrew Bible) as equal in importance to our faith as the New Testament. When we read Scripture, any Scripture, in a way that excludes, we fail to hear the true message of Jesus, the one who has the power and authority to bring us together in the unity of love, peace and joy. How can we more intentionally join the author

of Hebrews in celebrating the unifying power of Jesus?

Sept. 13
Confident and Committed
Lesson Scripture: Hebrews 4:14-5:10
Background Scripture: Hebrews 2:1-4:13
Key Verses: “Let’s hold on to the confession since we have a great high priest who passed through the heavens, who is Jesus, God’s Son. Let’s draw near to the throne of favor with confidence so that we can receive mercy and grace when we need help” (v. 14, 16).

The author of Hebrews continues to provide encouragement to strengthen the faith of the original recipients of this message. The author calls this community of believers to stay committed to the new way of life their faith in Jesus Christ has made possible. They are encouraged to remember their lives before and the reality of how God rescued them from the death and destruction of sin. Jesus as the Great High Priest has addressed humanity’s weakness manifested as a lack of confidence or feeling of inadequacy leading to a life of sin. Since Jesus has taken on humanity and not fallen to the temptations of sin, he is both the subject and the object of our confession. There is a sense that not being their authentic selves leads to sin, and Jesus gives them the example and the ability to overcome this weakness.

We join the original recipients in our tendency to concentrate on our weaknesses, and we need to hear the words found in verse 16. In the original context, the Holy Place, the Throne of God, was located within the Holy of Holies. Only the high priest on duty at the time was allowed in the Holy Place to present the blood of sacrifice on behalf of the community. But because of Jesus, we can come confidently before God’s throne seeking mercy and grace. We come with boldness and fearlessness, willing to conceal nothing of who we are before our holy and righteous God.

When we go before God’s throne we may feel like we know what we need, but God has worked out a suitable and well-timed response to our confession that exceeds

our understanding. How do our current worship and ministry opportunities support and encourage this type of committed confidence in Jesus our high priest?

Sept. 20
Hearts and Minds
Lesson Scripture: Hebrews 8:1-13
Background Scripture: Hebrews 7:1-28
Key Verse: “This is the covenant that I will make with the house of Israel after those days, says the Lord. I will place my laws in their minds and write them on their hearts. I will be their God, and they will be my people” (v. 10).

Hebrews 8 begins by further clarifying Jesus’ identity as the Great High Priest. The author continues to make distinctions between Jesus’ heavenly office and earthly high priest. Verses 4-6 declare Jesus to be superior to earthly high priest because their ministry is a poor imitation of Jesus’ priestly service. Jesus offers a new covenant with better promises and direct access to the forgiveness and restoration previously offered through the mediation of earthly priests. Jesus’ location at the right hand of the Father removes the need for the imitating earthly priests.

Verses 10-11 summarize this new covenant. God’s law will be located within the believer, no longer limited to the Holy Place and the law will be given to all people, great and small, so that everyone has access. This access means they no longer have an excuse for turning away from God’s instruction and way of life.

A misreading of verse 13 could cause us to fall into the temptation of dismissing Judaism as outdated and obsolete. However, verse 10 reminds us that the new covenant is still with Israel. God is faithful and is not capable of rescinding God’s promises. The newness of this covenant is found in the function of the law and the office of high priest. The sacrifice of animals by imperfect humans had to be repeated time and time again. Over time, because of humanity’s failings the repetition made the sacrifice an external event that did not facilitate behavioral change. This new covenant with a perfect and permanent high priest offers

an internal change of heart and mind.
The salvific work of Jesus Christ evidenced by the empty tomb makes this new covenant a reality and eliminates forever any need for replication. Our sins are forgiven, and we are free to worship the Lord and live in harmony with each other.

Sept. 27
Steady Encouragement
Lesson Scripture: Hebrews 10:19-25
Background Scripture: Hebrews 9:1-10:18
Key Verse: “Don’t stop meeting together with other believers, which some people have gotten into the habit of doing. Instead, encourage each other, especially as you see the day drawing near” (v. 25).

This section of the Book of Hebrews returns to the purpose of providing encouragement to the intended community of believers. The author returns to familiar themes of Jesus’ superiority to earthly high priests and his role in providing access to God the Father through his blood. Verse 20 offers a slightly different approach to this new way of seeking and receiving forgiveness for sins in the phrase, “new and living way.” The old way focused on the sacrifice of animals, a way that ends in death. This new way culminates in Jesus rising from the dead so that life triumphs over death.

The life of the believer takes on new meaning because of the birth, life, death, resurrection and ascension of Jesus. Verse 23 invites the original recipients of this sermon to have confidence in their confession of faith knowing Jesus is reliable and faithful.

The author closes this section of the sermon by shifting the focus from individual action to communal or corporate action. Verses 24 and 25 emphasize the need for mutual support and care. As we endeavor to live into the new and living way offered through Jesus Christ, we need others to “stir us up” (v. 24, ESV). There will be times when we don’t feel the new and living way and we might be tempted to go back to the old dead way. We don’t know when those times will come: therefore, we are instructed to meet regularly to encourage one another. As the saying goes, “If you stay ready, you don’t have to get ready.”

We are instructed to journey together as we seek to follow Jesus. How well do our churches accomplish the objective of meeting together regularly to stir each other up? Discuss ways we might better encourage one another in our faith in Jesus.



Children’s
Sermon

Enough for
everyone

Date: Sunday, Sept. 20
Scripture: Matthew 20:1-16
Time frame: 3 minutes (aiming for 3-5 minutes max)
Supplies: One sticker for each child (and a few extras).
Note: This children’s sermon could be more of a skit if you get a volunteer to play the role of a latecomer.
Do: Welcome the children warmly and invite them to sit down. Hold up a sheet of stickers.

Ask with big enthusiasm: Who likes stickers? (Pause.) Say: I brought enough stickers so everyone can have one!

(Hand each child a sticker.) Now imagine one more friend walked into church right now and came down for the children’s sermon. (If you are doing the skit version, have your volunteer come in now.)

Ask: Should they get a sticker, too? (Pause for answers.) I think so, too! Would anyone have to give up their sticker? (Pause; if a child does offer, take the sticker and share the sticker, thank them grandly and then say, “Look, I have more!” If no one offers, say: “No! I brought enough for everyone.”)

Today’s Bible story is about workers in a vineyard. Some workers started early in the morning. Other workers didn’t come until much later in the day. When it was time to be paid, the workers who came late still received enough. Some of the workers who had been there all day said, “That’s not fair!” But Jesus was teaching us something important in this parable. A parable is a story Jesus used to teach us something important. Jesus was teaching that God is generous. God doesn’t run out of love. God doesn’t run out of grace. There is enough for the people who came first. There is enough for the people who came last. Just like there were enough stickers for everyone, God’s love is big enough for everyone.

Ask: Can you think of someone you could be generous with this week? (Pause and affirm answers.) When we share, we remind people what God is like. God is generous.

Say: Will you pray with me?
Prayer: Dear God (echo), we love you (echo). Thank you for your generosity (echo). Help us to share (echo) and know there is enough (echo) because God is generous (echo). Amen (echo).

‘Groceries are expensive’

The Zion UMC Food Pantry is led by Terry Fellers, whom James has dubbed “the General.” Fellers said about 13 years ago, one of the church committees began brainstorming ideas for a congregation-wide outreach program. At that first giveaway, about 40 families came to the church for food, and for the early years, people came into the family life center to pick up donated items.

After COVID, they started a car line, and over the years, the numbers have grown steadily as word has spread and need has increased.

“It’s really started to go up lately—groceries are expensive!” Fellers said.

James agreed, noting the increase is a good snapshot of the area’s financial concern.

“I can tell how bad the economy is by how many people were there,” he said, noting the pantry draws people from all over the area.

Normally they start at 9:30 a.m., but people were already at the church at 7:13 when Fellers pulled into the church parking lot. So they pivoted, starting the distribution early.

James said the line was so long that they ended up winding the cars through the church graveyard.

“There are all kinds of theological and faith connections I see in this—people weaving their way through the graveyard in order to come to life and to life-giving food,” James said.

Food, toiletries and more

People who come to the Zion UMC Food Pantry receive what Fellers estimates is about \$100 worth of groceries—canned beans and corn, peanut butter, sugar, salt, flour, grits, spaghetti, macaroni, potatoes, eggs, bread, cornbread, lunchmeat and more.

Fellers said they try to do something extra at each giveaway, this time giving out fresh beans, tomatoes, cucumbers and squash. The grocery bill alone was \$17,000, all raised by volunteers.

And it’s not only food they distribute. People also receive toiletries, including soap, razor blades, toothpaste and deodorant, all donated by church members or delivered directly from Amazon.

At Christmas they also get a unisex gift to help them, such as towels.

“We’re a very giving church,” Fellers said.

Good evangelism

Fellers said the event is so well organized that it runs easily; everybody knows what to do.

The day before the pantry, a Food Lion tractor-trailer arrives with the bulk of the food, which is then unloaded and combined with other donated food and toiletries the church has received. On Friday night, roughly 60 volunteers bag all the items for easy distribution when the cars come through on Saturday.

James said volunteers are youth and adults and not only come from their church but also from all around the community. In a way it’s good evangelism in making God’s love known, he said—some volunteers are not part of a church, but they join with Zion UMC to do this effort in God’s name.

On Saturday morning, close to 50 volunteers gather to pass out the bags to cars, with some organizing the car line and praying with families, while others collect names and addresses so they can send them a postcard letting them know about future food pantry events.

James personally greets everybody who comes through the line.

“We don’t turn anybody away who comes. We see people who are Black, White, Hispanic, old, young—it is an awesome way to put your hands to the work of Christ for people,” James added.

‘It’s what we do’

Lee Koon, administrative assistant and youth leader at Zion, is one of those who volunteered at the August food pantry, there both Friday and Saturday to help.

“It’s a tradition,” she said. “It’s what we do at Zion, that feeling of everyone coming together for that common goal, that sense of community, that we’re doing some good.”

Fellers said those involved know they are not doing this for Zion but for something much more important.

“We are doing this for Jesus Christ—we are the hands.”

James called the ministry a breathtaking thing.

“I don’t have to direct anybody, I don’t have to inspire them to do it—it is something that is in their DNA.

“I’ve never been a part of a ministry like this, and you can see the impact of it immediately.”
